**We use the criteria outlined below for decision-making:**

- Organizations which meet local needs and serve people in Charles, Calvert, St. Mary's, Prince George's, and King George county areas.
- Motorcycle charity rides that start, stop, or end at our dealership.
- Motorcycle-related charities or organizations as well as Military and First responder organizations.
- Organizations which are lead, organized, or actively supported by customers of All American H-D.

**We can provide support to selected organizations in up to three ways:**

1. Merchandise Donation. Donations can be raffled or auctioned by the organization to generate funds.
2. Allowing an organization to conduct it's own fund-raising event at the dealership on a specific date. This includes poker run stops, ride registration points, etc.
3. Help promote charity rides by posting event publicity flyers on store bulletin boards and on-line.

**Advance notice helps. We look at all requests once or twice a month so please give us as much notice as you can. Planning in advance greatly aids in the logistics for charity rides and events must be worked out. Please understand that we will not be able to fill every request (nor will we be able to respond to every request). If approved, you will be notified by phone or email.
