

## FAN CAVE GIVEAWAY 2022 CONTEST OFFICIAL RULES

### **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED.**

**1. How to Enter:** The Fan Cave Giveaway 2022 Contest (the "Promotion") is open from 12:00pm (EDT) on Tuesday, October 4, 2022 to 6:00pm (EDT) on Saturday, October 29, 2022 ("Entry Period"). No purchase is necessary. During the entry period, you can enter by:

- Liking any Fan Cave Giveaway social media post from the Southside H-D Facebook page, tagging friends in it, and reposting it on your page (one entry for every person tagged, max 10 entries per week) There are no automatic entries for liking, posting, and tagging your friends. Physical entry forms must be filled out at our dealership, simply show an employee your comment under our post to receive entries.
- Visit a Southside H-D Open House (Oct 22 & 29), participate in the Pink Ride (Oct 9) or BSSC Charity Ride (Oct 8) (3 entries per person per day) Must present valid government issued photo ID to receive entries.
- Make a purchase at our dealership (1 entry per \$50 spent in Parts, Motorclothes, and Service) Participant will not receive entries for warranty/ESP work, collision work, or prepaid maintenance services. Only customer paid service tickets will receive entries.
- Buy a motorcycle (10 entries for each motorcycle) Bonus of 20 more entries if participant take a selfie with their salesman and share it on their social media page.

There is no limit to the amount of entries you may submit.
